Pursuant to the Interim Order issued by Administrative Law Judge Jeffrey Watson issued on October 23, 2019, counsel for the Pennsylvania Electric Company (“Penelec” or the “Company”) and its witnesses are available on January 9, 16, 21, or 24; and February 3 or 5, 2020 for the rescheduled evidentiary hearing. Unfortunately, the only availability that Ms. Dougherty has provided the Company for her and her witnesses during that period (February 18, 19, 27 and 28, 2020) do not match that of Penelec and its witnesses. 
