A prehearing conference was held on October 1, 2019 wherein the parties appeared and discussed potential resolution. Since the conference was held, Attorney Gregory Hook entered his appearance on behalf of Ms. Hook and West Penn forwarded various Commission decisions and smart meter historical materials.
