Dear Secretary Chiavetta:

On October 24, 2019, PPL Electric Utilities Corporation (“PPL Electric” or the “Company”) was electronically served with an Amended Formal Complaint filed by Donna and John Bengen (“Complainants”). The Complainants subsequently informed PPL Electric’s counsel that they intended that Complaint to be separately docketed as a Second Formal Complaint.

PPL Electric does not oppose the Amended Complaint receiving its own docket as a Second Formal Complaint. However, it is more efficient to address the issues raised in both Complaints in one proceeding because they both involve the same property, the same parties, and similar issues about the Company’s automated metering infrastructure (“AMI”) meters. Therefore, although PPL Electric does not oppose the Amended Complaint receiving its own docket as a Second Formal Complaint, PPL Electric will move to consolidate the two Complaint proceedings if that occurs. Consolidating the matters will eliminate the burden, time, and expense of separately litigating these cases for all parties.

In addition, PPL Electric observes that it must file its Answer to the Amended Complaint today. Given that the Complaint is still docketed as an Amended Complaint at Docket No. C-2019-3009735, PPL Electric will file its Answer as an Answer to the Amended Complaint at the current docket. To the extent that the Amended Complaint is later treated as a Second Formal Complaint, the Company respectfully requests that its Answer be transferred to that docket as well and treated as an Answer to the Second Formal Complaint.
