
This letter serves as Complainant's Status Report in accordance with the Interim Order issued on October 2, 2019.

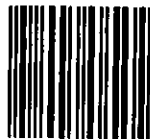
