**REQUEST FOR CALL-IN TELEPHONE HEARING**

AEP Energy requests that a call-in telephone hearing be permitted in this proceeding. Administrative Law Judge Angela T. Jones has scheduled an Initial Hearing in this case for Friday, November 22, 2019 at 10:00 a.m. in Philadelphia, PA. AEP Energy is requesting that for itself and any other party to this proceeding that is located outside the Commonwealth of Pennsylvania that such party be permitted to participate through a call-in telephonic means. This approach to accommodate physically distant parties was permitted in the Pennsylvania complaint proceeding of Amanda Klages v. West Penn Power Company & AEP Energy, Inc. in docket C-2019-3009612. For reference, a copy of the "Call-In Telephone Hearing Notice" in that proceeding is attached.

AEP Energy would, as provided in the referenced Notice, provide to the Administrative Law Judge three (3) copies of all hearing exhibits to which AEP Energy will refer during the hearing and serve the other parties with one copy each at least five (5) business days before the hearing.
