Dear Secretary Chiavetta:

On November 8, 2019, Peoples Natural Gas Company (“Peoples”) filed the *Petition of Peoples Natural Gas Company LLC for Permission to Withdraw the Petition of Peoples Natural Gas Company LLC for Approval of its Energy Efficiency and Conservation Plan* (“Petition”) at the above-captioned docket. The Petition was filed pursuant to Paragraph 67 of the Joint Petition for Approval of Settlement Stipulation (“Joint Petition”) approved by the Commission by Opinion and Order entered October 3, 2019, at Docket No. R-2018-3006818. The Petition requests, *inter alia*, that the Commission allow Peoples to withdraw its Energy Efficiency and Conservation Plan (“EE&CP”) Petition without prejudice. Petition ¶ 23.

Duquesne Light Company (“Duquesne Light”) does not object to Peoples’ request to withdraw its EE&CP Petition. Duquesne Light notes, however, that characterizing the withdrawal of the EE&CP Petition as “without prejudice” should not be construed to modify any of Peoples’ obligations under Paragraph 67 of the Joint Petition, which include limitations on the content and timing of future Peoples EE&CP proposals. Duquesne Light reserves all rights, including those provided for by Paragraph 67 of the Joint Petition, with respect to Peoples’ future EE&CP proposals.
