All others (corporation, partnership, association, trust or governmental agency or subdivision) must be represented by an attorney. An attorney representing you should file a Notice of Appearance before the scheduled hearing date.

If appropriate, we may be able to provide you with a telephonic hearing instead of an in-person hearing.
