In accordance with the Interim Order issued on October 3, 2019 in the above-referenced matter, this letter serves as a status report on behalf of Metropolitan Edison Company ("Met-Ed"). To date, Ms. Colantuono has not provided any responses to the discovery requests issued by Met-Ed in direct contradiction to the Interim Order which directed her to provide full and complete responses no later than October 28, 2019. Further, counsel for Met-Ed has not received any communication from Ms. Colantuono regarding a request for a protective order or agreement.

Given the lack of response from Ms. Colantuono to the Interim Order issued by Administrative Law Judge Jeffrey A. Watson despite the warning that failure to comply may result in the dismissal of her formal complaint, Met-Ed requests that its Motion to Dismiss be granted and the formal complaint of Ms. Colantuono be dismissed with prejudice.
