UNIFORM MOTOR CARRIER CARGO
INSURANCE ENDORSEMENT

It is agreed that:

1. The certification of the policy as proof of responsibility under the provisions of any State motor carrier law or regulations promulgated by any State Commission having jurisdiction with respect thereto, amends the policy to provide insurance for motor carrier cargo liability in accordance with the provisions of such law or regulations to the extent of the coverage and limits of liability required thereby, provided only that the insured agrees to reimburse the company for any payment made by the company which it would not have been obligated to make under the terms of this policy except by reason of the obligation assumed in making such certification.
2. The Uniform Motor Carrier Cargo Certificate of Insurance has been filed with the State Commissions indicated on the reverse side hereof.
3. This endorsement may not be canceled without cancellation of the policy to which it is attached. Such cancellation may be effected by the company or the insured giving thirty (30) days' notice in writing to the State Commission with which such certificate has been filed, such thirty (30) days' notice to commence to run from the date the notice is actually received in the office of such Commission.

To Whom It May Concern:

On August 26, 2019, the Bureau of Investigation and Enforcement instituted a Complaint against Phoenix Waste Services Inc, Respondent, alleging failure to maintain evidence of Liability and Cargo Insurance on file with this Commission, a violation of the Public Utility Code at 66 Pa C.S. §512, 52 Pa. Code §32.2(c), and 52 Pa. Code §32.11(a), §32.12(a) or §32.13(a).

In accordance with 52 Pa. Code §5.61, the Bureau of Investigation and Enforcement notified the Respondent that, unless its insurer files evidence of insurance with this Commission and Respondent pays the proposed fine, Respondent must file an Answer to the Complaint within twenty (20) days of the date of service. The Notice further specified that, if Respondent failed to answer the Complaint within twenty (20) days, the Bureau of Investigation and Enforcement would request the Commission issue an Order that imposes a penalty, which could include a fine, cancellation, or any other remedy.

The Complaint was served on the Respondent on August 30, 2019 for an answer due on September 16, 2019. To date, more than twenty (20) days later, Respondent has failed to file an Answer to the Complaint. On September 3, 2019, the Respondent's insurer filed evidence of liability insurance effective on August 30, 2019, and on September 13, 2019, the Respondent's insurer filed cargo insurance effective on August 16, 2019; however, Respondent has failed to pay the fine.

Therefore, the allegations in the Complaint are admitted and the Complaint is sustained.

Respondent shall pay a fine of five hundred dollars (\$500.00) for failure to maintain evidence of insurance on file with this Commission, 52 Pa. Code §32 within twenty (20) days from the date of this letter. Payment must be by certified check or money order, payable to the Commonwealth of Pennsylvania, 400 North Street, Harrisburg, PA 17120, as provided in the Public Utility Code, 66 Pa. C.S. §§3301 and 3315.

Respondent is hereby notified to cease and desist from further violations of the Public Utility Code, 66 Pa. C.S. §§101, et seq. and the regulations of the Commission, 52 Pa. Code §§1.1, et seq.

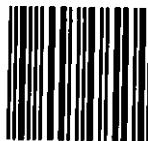
