This letter serves as an update to the status report provided on behalf of West Penn Power Company ("West Penn") on October 15, 2019. The parties have conferred and agreed that the evidentiary hearing be held as telephonic. Further, based upon the anticipated witnesses of both parties, the parties believe that hearings will need to be held over two different days. Based on their respective witness availability, they propose Day 1 as February 7, 2019, during which the Complainant will present his case in chief. Day 2 is requested to be held on either March 10 or 12, 2019, as a first preference, or March 17, 19, and 26, 2019, as a second preference. Day 2 would be used for West Penn to offer its rebuttal case.
