**Re: V. Wes Zimmerman v. Metropolitan Edison Company**

Dear Secretary Chiavetta:

In accordance with the Interim Order issued on July 24, 2019 in the above-referenced matter, this letter serves as a status report on behalf of Metropolitan Edison Company ("Met-Ed"). Mr. Zimmerman has failed to provide notification of his expert and factual witnesses by August 1, 2019 and failed to provide written direct testimony by October 7, 2019, in accordance with the Interim Order. Met-Ed timely provided notice of its expert and factual witnesses and avers that discovery between the parties is now complete.

As such, Met-Ed anticipates that the Complainant will not be presenting testimony in this matter or, if he does, it will be limited to his own factual testimony at the time of any evidentiary hearing. Therefore, Met-Ed anticipates that it will only need to present one witness, Mr. John Ahr, in order to rebut any factual testimony offered at that time. To the extent that Mr. Zimmerman is permitted to introduce additional witnesses for which notice and testimony was not provided, Met-Ed requests the right to conduct additional limited discovery, as well as reserves the right to revert to its original witness list.

Counsel for Met-Ed has conferred with Mr. Zimmerman regarding the scheduling of an evidentiary hearing. The parties have agreed to a telephonic hearing. Unfortunately, counsel for Met-Ed and its witness are not available for a hearing in December 2019. Instead, the parties offer the following dates for hearing availability in January: January 22, 23, 27, 29, 30 and 31, 2020.<sup>1</sup>

<sup>1</sup> To the extent Mr. Zimmerman requests to introduce additional witnesses for the hearing, it is anticipated that revised dates and two days of hearing may be needed.

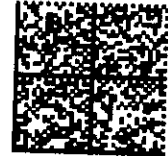
