Dear Secretary Chiavetta:

In accordance with the Interim Order issued on July 23, 2019 in the above-referenced matter, this letter serves as a status report on behalf of Metropolitan Edison Company ("Met-Ed"). The Complainants have failed to provide notification of their expert and factual witnesses by October 1, 2019 in accordance with the Interim Order. Met-Ed timely provided notice of its expert and factual witnesses and avers that discovery between the parties is now complete.¹

As such, Met-Ed anticipates that the Complainants will not be presenting testimony in this matter or, if they do, it will be limited to their own factual testimony at the time of any evidentiary hearing. Therefore, Met-Ed anticipates that it will only need to present one witness, Mr. John Ahr, in order to rebut any factual testimony offered at that time. To that end, Met-Ed requests that a one-day telephonic evidentiary hearing be scheduled. Counsel for Met-Ed and its witness are available for a telephonic hearing as follows: January 9, 13, 16, 21, 23, 24, 27, 29, 31 or February 4, 10, 12, 14, 18-21, 28, 2020.
