Re: PECO Energy Company's 2019-2021 Universal Service and Energy Conservation Plan ("USECP"), Docket Nos. M-2018-3005795 and M-2019-3012601

Dear Secretary Chiavetta:

In its Order in Docket M-2019-2032601 (entered October 3, 2019) addressing USECP filing schedules and independent evaluation filing schedules, the Pennsylvania Public Utility Commission ("Commission") directed PECO Energy Company ("PECO") to file an addendum to its USECP at Docket M-2018-3005795 to provide enrollment and budgetary projections based on any additional years added to its pending proposed USECP.

In its Order in Docket No. M-2019-3012599 (entered November 25, 2019) staying Paragraphs 6, 7, and 8 of its CAP Policy Statement Order, the Commission specifically noted:

This stay does not affect other filing obligations due on January 6, 2020, pursuant to our recent modification of the filing schedule in *USECP Filing Schedule*, Docket No. M-2019-3012601 (order entered on October 3, 2019) or pursuant to other utility-specific orders.

PECO interprets these two Orders as requiring it to file an addendum expanding its pending USECP from 2019-2021 to 2019-2024, including budgetary and enrollment projections, by January 6, 2020. Given the Commission's consideration of the Petitions for Reconsideration/Clarification in its CAP Policy Statement Order, PECO submits that it would be difficult to provide the updated enrollment and budgetary projections requested by the Commission. Indeed, the data it would be updating will vary significantly depending upon the results of the Commission's Order on Reconsideration/Clarification in Docket M-2019-3012599.


For these reasons, PECO hereby requests a suspension of the USECP addendum filing required per the October 3, 2019 Order in Docket M-2019-20302601 and the November 25, 2019 Order


