Respondent, Sterling Transport Co., Inc. ("Sterling Transport"), has paid the amount sought by the Pennsylvania Public Utility Commission's ("PUC") Bureau of Investigation and Enforcement ("I&E") and has caused its insurer to file evidence of liability insurance with the PUC in order to resolve the above-docketed complaint.
