
On or about August 29, 2019, Mr. John A. Smith, Jr., a complainant in the above-referenced proceeding, filed a letter indicating that he had sold his property at 274 Big Bend Road, Emlenton, PA 16373 to Mr. Andrew and Katelyn Stutzman. Mr. Smith indicated in the letter that he relinquished and conveyed his rights to any payment in the above-referenced proceeding to Mr. and Mrs. Stutzman as a result of selling the property. Mr. Smith confirmed this in a subsequent letter to National Fuel Gas Distribution Corporation ("Distribution") dated December 4, 2019. This letter will end and finalize any further and future discussions in said matter. If I am notified in any manner from you or National Fuel in this regard, I will pursue litigation in regards to over 23 years of harassing behavior from National Fuel, as well as many other issues.


