In accordance with the Interim Order issued on December 4, 2019 in the above-referenced matter, this letter serves as an updated status report on behalf of West Penn Power Company ("Company"). Counsel for the Company was able to reach Mr. and Mrs. Sabatini to inquire regarding their availability for a one-day hearing to be held in person in Pittsburgh on one of the dates specified in the Interim Order. Unfortunately, counsel for the Company and its witness are unavailable on January 14 or 30, 2019 due to other previously-scheduled hearings. Mr. Sabatini has further indicated that he and Mrs. Sabatini were not available on January 7 or 23, 2019. 
