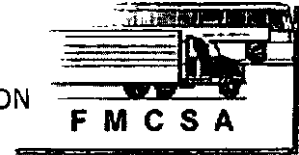

Attached you will find the Form E. Since I spoke with Evan Ricardo from the PUC on the 18th, I have had to call and email National General Insurance Company customer service, underwriting and product management in order to get this company to issue this filing. The insurer could not understand that the two property brokerage authorities that the principals own that are also registered to the same mailing address as Big Dog could have zero potential impact on liability relating to Big Dog. It took from 10/30/2019 through 12/31/2019 to finally speak with an underwriter who could competently work through this logic and documentation and release the filing!

What else is needed in order to get Big Dog Truck Lines, Inc. back into compliance and out of the status of SUSPENDED with the PUC as it relates to insurance and filings? National General is unable to upload to mcinfo.org. The filing is attached.

It is my understanding that the Form H was electronically uploaded by Great American however, we are also including that as well.

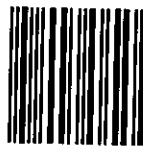
