Dear Secretary Chiavetta:

In accordance with the Interim Order issued on November 26, 2019 in the above-referenced matter, this letter serves as a status report on behalf of Metropolitan Edison Company ("Met-Ed"). Met-Ed timely provided notice of its expert and factual witnesses. While Ms. Yewcic did not timely provide a witness notice in accordance with the Interim Order, she did provide a witness list in her responses to the Discovery Requests propounded by Met-Ed. Further, Met-Ed avers that discovery between the parties is now complete.

Based upon the information provided by Ms. Yewcic in her discovery responses, Met-Ed anticipates that the Complainant will not be presenting expert testimony in this matter, only factual testimony at the time of any evidentiary hearing. Therefore, Met-Ed anticipates that it will only need to present one witness, Mr. John Ahr, in order to rebut any factual testimony offered at that time.

Counsel for Met-Ed has conferred with Mr. Tom Yewcic, on behalf of Mrs. Yewcic, regarding the scheduling of an evidentiary hearing. The parties have agreed to a telephonic hearing with a preference for a hearing date of February 21, 2020. If that date is not acceptable to Administrative Law Judge Jeffrey Watson, the parties are otherwise available for a hearing on February 19-20, 2020.
