### **AMENDATORY ORDER**

By the Commission:

On August 15, 2017, the Illinois Commerce Commission ("Commerce") granted Aggressive Energy LLC's ("Applicant") verified Application requesting a certificate of service authority to operate as an alternative retail electric supplier ("ARES") in Illinois pursuant to Section 16-115 of the Public Utilities Act ("Act"), 220 ILCS 5/1-101 et seq., and 83 Ill. Adm. Code 451 ("Part 451"). The Commission's Order granted Applicant authority to provide service to all eligible residential and commercial retail customers, but Applicant seeks to serve only non-residential customers in Commonwealth Edison Company's service territory.

The Order incorrectly included references to Subpart D of Part 451, which is inapplicable to Applicant's requested certificate. Therefore, the fourth and fifth paragraphs in Section III.A. and the third paragraph of Section III.B. are deleted.

The Order also incorrectly identified Applicant's service authority. The Commission concludes, therefore, that Applicant's request for a certificate of service authority to operate as an ARES in Illinois should be amended and should grant the following authority:

### CERTIFICATE OF SERVICE AUTHORITY

IT IS CERTIFIED that Aggressive Energy LLC is granted service authority to operate as an Alternative Retail Electric Supplier as follows:

SERVICES TO BE PROVIDED: The sale of electricity and power.

CUSTOMERS TO BE SERVED: All eligible non-residential retail customers.

GEOGRAPHIC REGION(S) SERVED: For the sale of electricity and power in the service area of Commonwealth Edison Company.

IT IS THEREFORE ORDERED by the Illinois Commerce Commission that Aggressive Energy LLC is hereby granted a Certificate of Service Authority as set forth in this Order.

IT IS THEREFORE ORDERED that the Order entered by the Commission on August 15, 2017 is amended by the above language as noted herein. In all other respects, the Order remains the same and in full force and effect.

IT IS FURTHER ORDERED that, subject to the provisions of Section 10-113 of the Public Utilities Act and 83 III. Adm. Code 200.880, this Order is final; it is not subject to the Administrative Review Law.
