

Grid Power Direct LLC will be filing an application with the Pennsylvania Public Utility Commission ("PUC") for a license to supply electricity or electric generation services as a generator and supplier of electric power. The PUC may consider this application without a hearing. 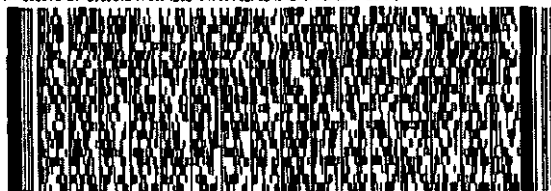

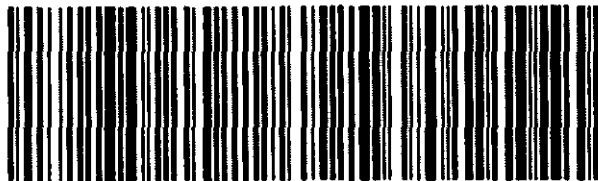
