Dear Secretary Chiavetta:

In accordance with the Interim Order issued on December 23, 2019 in the above-referenced matter, this letter serves as a status report on behalf of Metropolitan Edison Company ("Met-Ed"). Mr. Habrial has advised that he will not be presenting any expert witnesses by letter dated August 8, 2019. Met-Ed timely provided notice of its expert and factual witnesses and avers that discovery between the parties is now complete.

As such, Met-Ed anticipates that it will only need to present one witness, Mr. John Ahr, in order to rebut any factual testimony offered at the evidentiary hearing. Based upon this information, Met-Ed believes that the evidentiary hearing can be completed in one day, rather than two separate days.

By letter dated December 31, 2019, Mr. Habrial provided a status report regarding the scheduling of an evidentiary hearing. Met-Ed agrees to Mr. Habrial's request for an in-person hearing to be held in Harrisburg. Further, based upon the dates provided in the Interim Order and Mr. Habrial's availability, counsel for Met-Ed and its witness are available for an evidentiary hearing as follows: March 2, 5 and 19, 2020.
