UGI and Pennsylvania Electric has capitalized on the peoples necessity, forcing them to pay tariffs through unlawful conversion, forced contracts, and pushing what they call "Services" and "benefits" upon the people. These "contracts" are of false and misleading statements of fictitious conveyance of language and deprivation of my rights. Why did you modify grammar to extort money from me and others. I am not a government employee and I do not have any money. There is no other source of necessity available to me. Without Electricity I could not legally contain a fire in my home to cook nutritional meals for myself. I need beans and rice cooked for protein and carbohydrates to sustain my body each day or I will become malnourished. I grow my own food to sustain my health until the following year of harvest. I freeze corn, green beans and Cabbage. If I could not freeze my food, I would die. I need fresh food frozen so I can eat it throughout the year. Malnutrition can lead to serious health issues and I could die because I had no electricity. If I had no bathe I'd develop bacterial infections

which could become contagious to others, I would smell badly, resulting in others not wanting to be around me, this would cause a deep depression, which would cause me medical problems, not only physically ~~but~~ mentally, I would die because I don't have money.

If I did not have electricity from Pennsylvania Electric I would not be able to dispose of my own feces and urine unable to flush the toilet.

Feces and urine, if not disposed of would create a deadly bacterium severely harmful if breathed in, this infection could kill as a result of not being able to use Pennsylvania Electric.

I am forced to use Pennsylvania Electric and UGI or I will die. Pennsylvania Electric provided lights as well throughout my home. It is impossible to live in my home without Electricity.

I cannot live without these "services". Without the use of electricity my body will be full of infection, I won't be able to fight the infection because my body will be malnourished and I would be severely depressed and sad because all I would want is to bathe brush my teeth, eat cook and to flush the toilet of bacteria that I dispose of. Electric is not a luxury, but a necessity of life, and should not be denied.

Therefore,

It is ordered:

1. that I, michelle stailey, the living, breathing soul continues receiving the necessary "services" that all human beings require for life. The services of UGI Utilities, Inc. (Gas Division) and Pennsylvania Electric Company, to continue to provide me "services" (the use of necessity.)
2. that I am given the proper and correct information and knowledge to open a Treasury Direct Account, which would allow me to debit this imposed debt on me, the living, breathing, able to think and 'capable of thought' soul.
3. that the Secretary of Commission fully investigate both these cases
4. that the secretary of Commission review all court records/recordings of case(s) C-2019-3008847 and C-2019-3008867 to prove the "findings of facts" stated by Judge Buckley were not consistent with my testimony. His "findings of fact" are untrue.
5. that I am scheduled and notified to appear before you on a specific day to discuss the fraud both of these companies

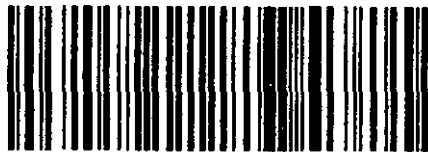

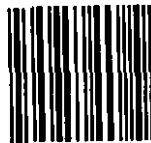
