Enclosed are two (2) copies of updates for 269th Revised Page 2, 21st Revised Page 2-C, 7th Revised Page 101, 4th Revised Page 102, and 1st Revised Page 102-A for Stumpf Moving and Storage, William C. Stumpf, t/d/b/a (PA PUC #A-00099993) in Pittsburgh PA. This filing is for an INCREASE in their Local Hourly Rates (moves traveling 40 miles and less between points within Pennsylvania), an INCREASE of their Intrastate Transportation Rates (moves traveling in excess of 40 miles between points within Pennsylvania), as well as, the ELIMINATION of the \$100.00 deductible Full Value Protection Coverage option and an INCREASE in the charges for \$250.00 deductible and \$500.00 deductible Full Value Protection Coverage. Also CHANGED the top of Pages 101 and 102 showing that rates apply on shipments transported between points in Pennsylvania as Stumpf Moving and Storage, William C. Stumpf, t/d/b/a, was "grandfathered" for statewide operating authority in May 2015. The effective date for these exceptions in Tariff 54 is February 27th.
