


**PETITION FOR EXTENSION OF TIME TO FILE RESPONSE TO COMPLAINANT’S
PETITION FOR RECONSIDERATION**

PECO Energy Company ("PECO" or the "Petitioner") hereby submits this Petition for Extension of Time to File a Response to Complainant Judith Benvenger’s (“Complainant”) Petition for Reconsideration in the above-captioned matter. The basis of this request for an extension of time to file a response is because Complainant never served a copy of her petition for reconsideration upon PECO. Pursuant to Pursuant to 52 Pa. Code § 5.572 (B), Complainant was required to – but failed to – serve a copy of her petition for reconsideration upon PECO. While Complainant filed her petition for reconsideration on January 2, 2020, PECO did not become aware of the petition until January 23, 2020, when it received from the PUC the Order dated January 16, 2020 (which granted the petition for rehearing or reconsideration pending further review of, and consideration on, the merits). Due to the short period of time by which PECO must respond to Complainant’s petition for reconsideration, PECO respectfully requests an extension of time to file a response to the Complainant’s petition, requesting to have until February 3, 2020 (which would be 10 days after PECO learned of the filing of the petition of reconsideration on January 23, 2020 as discussed above) or later to respond to the petition for reconsideration.

WHEREFORE, PECO respectfully requests to have until February 3, 2020 or later to respond to Complainant's petition for reconsideration.


