Damage Release

KNOW ALL MEN BY THESE PRESENTS, that Township of Damascus, of 60 Conklin Hill Road, Damascus, Pennsylvania 18415,

for and in consideration of the sum of Eleven Thousand Nine Hundred Eighty-Two Dollars and 87/100 (\$11,982.87) in hand paid by **PPL Electric Utilities Corporation**, the receipt whereof

is hereby acknowledged, do hereby remise, release, quitclaim and forever discharge the said PPL Electric Utilities Corporation, its respective officers, agents, employees, successors, assigns and all persons or entities, whether or not named herein, who may be jointly or severally liable, of and from all suits, claims, demands, actions, damages and claims for damages or contribution whatsoever arising out of or resulting from any injury, loss or damage that may have been caused to **reimbursement for road repair**, crops, grain, land, and personal property in the Township of

Damascus, County of Wayne, Commonwealth of Pennsylvania, by reason of the construction, reconstruction and/or maintenance by the said PPL Electric Utilities Corporation of its overhead and/or underground electric line facilities, upon, over, under and across said property to the day of the date of these presents. Owner shall maintain in the strictest confidence the terms of this Agreement, including the amount payable hereunder.

This Agreement is between a public utility and a municipal corporation and is therefore subject to Pennsylvania Public Utility Commission ("PUC") review pursuant to 66 Pa.C.S.A. § 507. The Effective Date of this Agreement shall be the later of i) thirty (30) days from the date that PPL submits the Agreement to the PUC; or ii) if the PUC opens an investigation of the Agreement, on the date the PUC approves the Agreement.


