Enclosed are two (2) copies of updates for 272<sup>nd</sup> Revised Page 2, 22<sup>nd</sup> Revised Page 2-C, 62<sup>nd</sup> Revised Page 7, 6<sup>th</sup> Revised Page 107-A, Original Page 107-A-1, and Original Page 107-A-2 for Weleski Transfer, Inc. (PA PUC #A-00096502) in Tarentum PA. This filing is for an INCREASE in their Non-Peak Season transportation rates and the ADDITION of Peak Season transportation rates for Intrastate moves (shipments traveling in excess of 40 miles between points within Pennsylvania) and the ADDITION of a cancellation fee. Also CHANGED the verbiage at the top of Pages 107-A and 107-A-1 showing that rates apply on shipments transported between points in Pennsylvania as Weleski Transfer, Inc. was "grandfathered" for statewide operating authority in May 2015.
