**PETITION FOR RECONSIDERATION**


1. Admitted. It is admitted that YOUNG'S BUS LINES, INC. failed to maintain evidence of insurance on file with the Pennsylvania Public Utility Commission ("Commission").
2. Admitted in part; denied in part. Respondent owner ("Owner") of YOUNG'S BUS LINES, INC. is deceased and the business has been terminated.
3. Admitted. A Certificate of Public Convenience was issued by the Commission on September 27, 1990.
4. Admitted in part; denied in part. It is admitted that Liability and Cargo insurance has lapsed. The insurance lapse was caused by the untimely death of the Owner on July 10, 2019.
5. Admitted. It is admitted the Respondent failed to maintain insurance. Said failure was caused by Respondent's accidental death on July 10, 2019 and the confusion precipitated by said untimely death.

**WHEREFORE**, the Respondent agrees to the cancellation of the certificate of public convenience, but prays the Commission to rescind the imposition of the fine due to the death of the Respondent and the termination of the service at the time of his death.
