

Enclosed are two (2) copies of updates for 278th Revised Page 2, 176th Revised Page 2-A, 1st Revised Page 64-B, 1st Revised Page 64-C, and 1st Revised Page 64-D for Legacy Enterprise Group, LLC, dba Anchor Moving and Storage (PA PUC #A-8916263) in Moorestown NJ. NOTE 1 - MINIMUM TRANSPORTATION CHARGES: Sundays and Holidays: Seven (7) hours at rates named in Column 2 plus applicable travel charge. Other than Sundays and Holidays: Five (5) hours at rates named in Column 3 or 4 plus applicable travel charge.

▲ NOTE 2 - LAYOVER

(a) Holding furniture on truck at shipper's need or request will be allowable for up to two (2) weeks. If items cannot be removed at destination within two (2) weeks, items will then be moved into storage at all prevailing rates.

(b) Rates - First night is \$125.00. Each additional night is \$125.00. Travel time on delivery day will be added using the distances listed in Note 4 below. On each day of service, the prevailing minimum charges will apply.

▲ NOTE 3 - If service commences at the request of the shipper after 12:00PM, overtime rates shown in Column 4 will apply starting at 5:00PM.

▲ NOTE 4 - The following travel charges will apply when distance from:

- (1) Origin and destination are within 10 air miles of carrier's terminal - 1 hour at applicable rates.
- (2) Origin or destination is between 11 and 20 air miles of carrier's terminal - 1.5 hours at applicable rates.
- (3) Origin or destination is between 21 and 30 air miles of carrier's terminal - 2 hours at applicable rates.
- (4) Origin or destination is between 31 and 40 miles of carrier's terminal - 3 hours at applicable rates.

NOTE 5 - When a Holiday fall on a Saturday, the rates named in Columns 1 and 2 shall be applicable.
