SIXTY-DAY STATUS REPORT

Dear Deputy Chief Administrative Law Judge Cheskis:

In accordance with the Fourth Scheduling Order in the above-referenced matters, this correspondence is to provide you with a status report on negotiations toward a settlement. (Please note: A draft of this status report was previously shared with all parties, and none expressed an objection.)

On or about October 9, 2019, Pennsylvania-American Water Company ("PAWC"), the Office of Consumer Advocate ("OCA") and the Pennsylvania Public Utility Commission's Bureau of Investigation and Enforcement ("I&E") reached an agreement in principle for resolving these matters, subject to the negotiation of an acceptable asset purchase agreement ("APA") between PAWC and Winola Water Company ("Winola"). Aqua Pennsylvania, Inc. ("Aqua"), did not join the agreement, nor did it oppose the agreement.

Since the previous status report was filed on December 16, 2019, Winola has retained an attorney to assist it in negotiating the APA. In addition, PAWC has sent a draft APA to Mr. Scartelli, and the parties are in negotiations to finalize the agreement.


At this time, the parties see no need to reestablish a procedural schedule in this matter. PAWC and Winola will continue their efforts to negotiate a mutually-acceptable APA, and will submit another status report to you in 60 days, as required by the Fourth Scheduling Order.


