Bucks County Transport, Inc., Bux-Mont Transportation, Inc., Easton Coach Company, Suburban Transit Network, Inc., and Tri County Transit Service, Inc., collectively, Joint Protestants to the above-captioned Application ("Joint Protestants"), have engaged in discussions with counsel for Senior Care Centers of Pennsylvania, Inc. ("Applicant"). As part of those discussions, the Joint Protestants have received clarifications from the Applicant regarding issues raised in their Protest of this Application. Specifically, Applicant clarified the location of their proposed transportation and their intentions regarding the "fixed and assigned routes" referenced in their Application. It is the Joint Protestants' understanding that the Applicant intends to provide service to its own customers at its own facilities pursuant to a schedule dependent upon the customers' needs on a day-to-day basis.
