In accordance with the Interim Order issued on January 14, 2020 in the above-referenced matter and in response to the Updated Status Report and Request for Accommodations filed by Mr. Jennings, this letter serves as a status report on behalf of West Penn Power Company ("West Penn"). Counsel for West Penn has conferred with Mr. Jennings regarding the scheduling of an evidentiary hearing and West Penn has no objection to Mr. Jennings's request for an in-person hearing to be held in Pittsburgh, Pennsylvania.


