RULES & REGULATIONS

1. Advance reservations are required and must be made fifteen (15) minutes prior to service being rendered. Any Wheelchair Van reservation made less than two (2) hours to travel time will be charged an additional fee.
2. Rates for mileage are determined by the odometer of the vehicle in use and begin when the vehicle leaves the passenger's premises. The final mileage reading is determined upon drop-off of the passenger. A mileage fee will be charged for any pick up greater than 5 miles from the garage.
3. Additional expenses necessitated by or incurred at the request of the passengers, including but not limited to, highway tolls, bridge tolls, entrance fees and parking, shall be added to the charge of the trip. Expenses for driver's lodging and meals while on trips out of town which are in excess of ten (10) hours will be added to the basic charge.
4. If any trip requires the vehicle and driver to remain at a destination overnight, or at any point en route to a destination overnight, the patron will be responsible for providing carrier's driver with accommodations at an overnight facility (motel, hotel) being utilized by the patron, and all meals required by the carrier's driver. Expenses for driver's lodging and meals while on trips out of town which are in excess of eight (8) hours will be added to the basic charge.
5. Trips on the following Holidays are subject to additional fees as listed in RATES for Wheelchair Vans ONLY, No additional charges for trips in a Sedan or SUV:
 - New Year's Eve and New Year's Day
 - Memorial Day
 - Independence Day
 - Labor Day
 - Thanksgiving Day and Black Friday (Day after Thanksgiving)
 - Christmas Eve and Christmas Day
6. Deposit: All reservations require a deposit of not more than 20% of the quoted charter price.
 - a. Deposits are subject to forfeiture of not more than 50% of the deposit if the charter is cancelled by the customer more than 15 but less than 30 days prior to the date the transportation was to depart.
 - b. Deposits are subject to forfeiture of not more than the total amount of the deposit if the cancellation occurs within 15 days prior to the date the transportation was to depart.
7. **CONTRACT SERVICES**

Contract services will be for a term of not less than 30 days for pre-qualified persons under a federal, state, county or municipal government agency contract. Rates for the

services will be specified in the respective contracts, copies of which, including any amendments thereto, are to be filed with the Commission as executed to become effective on one day's notice.

SCHEDULE OF RATES

(Per Person)

Services are available All Hours All Days, 24/7/365
Rates for Sedan and SUV Services are always as listed below

Sedan Service: \$2.50 per mile, or any fraction thereof.
SUV Service: \$2.75 per mile, or any fraction thereof.

Any pick up greater than five (5) miles from the garage will be charged fifty cents (.50) per mile after the first five miles until the point of pickup, and then the mileage charge as listed for the type of vehicle requested.

Wheelchair Van Flat Rates: For all loaded miles from the point of pickup to point of drop-off (one way)

Standard and Evening Hours: 12:00 AM to 12:00AM
Wheelchair Van: \$55.00

Weekend and Holiday Hours: 12:00 AM to 12:00 AM
Wheelchair Van: \$65.00

Wheelchair Van Mileage rate: \$2.50 per mile, or any fraction thereof, applies in addition to the Flat Rate stated above on all loaded miles, after the first one (1) mile, from the point of pick-up to the final destination for wheelchair van.

Reservations: Any Reservation made less than two (2) hours before travel time will be charged an additional \$25.00 fee for Wheelchair Van trips only.

Waiting Time At Origin: After the first Five (5) minutes of free time the passenger will be charged at the rate of \$7.50 for every fifteen (15) minute increment, or any fraction thereof.

Waiting Time During Trip: If the driver is requested to wait for a customer at the destination or during a trip, there will be an additional waiting time charge of \$7.50 for every fifteen (15) minute increment, or any fraction thereof.
