Subject: Exceptions

Greetings and good day to all who shall receive this honorable present called EXCEPTIONS regarding the Public Utility Commissions obligation to uphold support and defend the Constitution.

Whereas I present to you in good faith the following information. According to the PUC's own website that outlines their duties and responsibility to the people. The PUC regulates the rates and service of investor-owned water and wastewater companies, along with some municipal systems that serve customers outside their boundaries. Since viable water systems are essential to strong Pennsylvania communities, rates must be set to reflect prudently incurred costs of providing service while working to ensure infrastructure integrity. The PUC and its commissioners are bound by the Constitution and have taken an oath to support protect and defend the Constitution. As previously noted I am an aborigine American also known as "Indian".

Whereas, Article 1, Section 2, Clause 3, of the Constitution clearly outlines "excluding Indians not taxed." The word taxed is defined as such according to its original meaning etymology dictionary: Taxed (n) c. 1300, "impose a tax on," from Old French *taxer* "impose a tax" (13c.) and directly from Latin *taxare* "evaluate, estimate, assess, handle," also "censure, charge," probably a frequentative form of *tangere* "to touch," from PIE root ***tag-** "to touch, handle." Sense of "to burden, put a strain on" first recorded early 14c.; that of "censure, reprove" is from 1560s. Its use in Luke ii for Greek *apographein* "to enter on a list, enroll" is due to Tyndale. Related: *Taxed*; *taxing*.


Whereas, ignorance of the law is no excuse and law is specific never vague in it's meaning. The PUC was created to settle disputes in a non bias manner between two parties. The relief sought is not beyond the jurisdictional boundaries of the PUC.

Whereas, House Congress Resolution 331, A Concurrent Resolution, clearly states our government-to-government relationship with the United States government and corporations. The aforementioned bodies of law, clearly defines jurisdiction, trust responsibility and obligation of government entities, agents, municipalities and so called private corporations" to me and my people. To "charge" my people for the use of resources and or deny me or my people free use of our natural resources is a clear violation of law and constitutes an overt act of genocide, fraud and racketeering.

Whereas, PWSA ET al, has been using fraudulent and colonization tactics upon me and my people, who are of aborigine American ancestry, heritage and pedigree. These charges (any and all charges), fees and proceedings are unlawful and must be addressed for immediate remedy. According to American Declaration on the Rights of Indigenous People Article XXXIII, XXXIV, XXV Section 1,2,3,4, and 5, XXIX section 4. For instance in Article XXV Section 1 and 2 read as follows: Section 1 of Article XXV 1.) Indigenous people have the right to maintain and strengthen their distinctive spiritual ,cultural, and material relationship with their land, territories, and resources and to uphold their responsibilities to preserve them for themselves and future generations. Section 2 of Article XXV reads as such: Indigenous peoples have the right to the lands, territories and resources which they have traditionally owned, occupied or otherwise used or acquired.

My people and I have been wonderfully overjoyed to receive this honor ancestral lineage and heritage to the American continent which is the land of my birthright by pedigree.

Whereas I, Ikhana-hal-makina, present to your office, officers and staff in good faith and honor to uphold your oath to the constitution and to uphold and honor the constitutionally recognized government-to-government relationship with I and my people, that are known by some as "Indian tribes". Our acknowledged relationship has been the cornerstone of your Nation's official "Indian policy" and International laws on human and indigenous people rights. Please proceed in "prompt decision" to remedy and acknowledge my heritage, rights and status by correcting your system to reflect my correct title Ikhana-hal-makina and remove the colorable misnomer of **SHAWNECE MOORE** or any derivatives thereof to my proper title Ikhana-hal-makina, which may appear on several documents and forms. My title shall not be affixed to any documents not approved by myself.

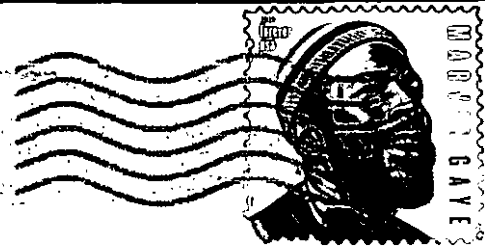
