The purpose of this letter is to notify you that, pursuant to 52 Pa. Code § 5.61(d), this matter involves a rate proceeding and Philadelphia Gas Works ("PGW") is electing not to file a formal answer to the complaint filed by the Office of Consumer Advocate ("OCA"), the Office of Small Business Advocate ("OSBA"), nor to any subsequently filed complaints.

On January 30, 2020, PGW filed its supporting information for the pre-filing of its annual 2020-2021 Gas Cost Rate ("GCR") at Docket Number R-2020-3017934. PGW expects to file its definitive GCR filing on or before March 2, 2020. The OCA filed a Formal Complaint on February 11, 2020 at Docket No. C-2020-3018205. The OSBA filed a Formal Complaint on February 21, 2020 at Docket No. C-2020-3018856.

Pursuant to 52 Pa. Code § 5.61(d), PGW has elected to not answer either complaint since they are complaints in a rate proceeding. Please contact me with any questions.


