
Re: Notice of Transfer of Natural Gas Supply Customers from Mack Oil Company (A-125017) to Rhoads Energy (A-2009-2138310).

Dear Secretary Chiavetta:

The purpose of this letter is to provide notice to the Commission, Statutory Parties and affected Natural Gas Distribution Companies of the impending transfer of all the customers of Mack Oil Company to Rhoads Energy. Mack Oil Company will cease natural gas supply service after the transfer is completed. Mack expects to seek abandonment of its license once all customers are transferred, or after April 1, 2020. The transaction closed on January 30, 2020 with an effective date of February 1, 2020. It is expected that customers will begin to be switched beginning with meter reads on or after March 11, 2020. Mack Oil Company serves customers only in the PECO service territory, and all of Mack Oil Company's contracts with Natural Gas Customers are assignable. Rhoads Energy is licensed to provide service in the PECO service territory.

Mack and Rhoads intend to notify customers beginning immediately after the close of the transaction and will provide such notice in substantially the same form as the notice attached hereto. Both Mack Oil Company and Rhoads Energy are current with all assessments owed to the Commission. If there are any questions or concerns regarding this notice, please contact the undersigned.


