Re: Rescission of final order

PUC-Secretary Bureau,

We are writing this letter as a formal request to have PUC authorities, A-705903 & A-2016-2534040, be reinsated and the final order to have our authorities rescinded be reversed.

It recently came to our attention that we were non-compliant with our yearly assessments. Unfortunately, we never received any forms from the PUC regarding this matter. We spoke with the assessment office on February 12, 2020 and were informed that all correspondence had been sent to our previous location at 1024A First Ave Hellertown, PA 18055. We have not been at that location for the better part of a decade.

Cassi Pomeriy, from the assessment department, informed us that there had been a clerical error on their part which caused our mail to be sent to the wrong address.

The PUC has been aware of our one and only location at 1866 Auburn Street Bethlehem, PA 18015 for many years. We had a visit from an enforcement agent a few years ago and have always made a concerted effort to remain compliant with the PUC.


We have enclosed copies of our PUC authorities which were issued in 2015 & 2016. Our authorities clearly state our current location at 1866 Auburn Street Bethlehem, PA 18015.

As we stated previously, we have always made an effort to remain compliant with the PUC and would have continued to be compliant if we had received the appropriate forms from the assessment department.

Due to the clerical error and any oversight on our part we are asking that the final rescindment order be reversed and our authorities be reinstated. Going forward we will ensure that all forms are submitted in a timely manner and will remain compliant with the PUC.

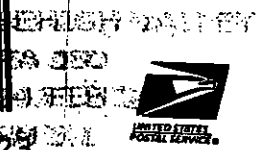

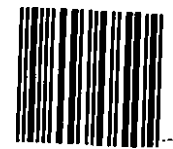
