Enclosed are two (2) copies of updates for 282nd Revised Page 2 and 8th Revised Page 15-B for Alpha International Movers, Inc. (PA PUC #A-00117495) in Sciota PA. This filing is for an INCREASE in their Additional Men and Supervisors rates for Monday-Friday, 7:01AM to 5:00PM (rates in Columns 2 and 4 remain the same) and a CHANGE in their Minimum Transportation Charges and Travel Time Fees. They are also ADDING charges for moving safes, cost of container and labor for flat screen TVs, and overnight holding fee. I changed the verbiage at the top of 8th Revised Page 15-B showing that rates apply on shipments transported between points in Pennsylvania as Alpha International Movers, Inc. was "grandfathered" for statewide operating authority in May 2015. ▲ **NOTE 1 - MINIMUM TRANSPORTATION CHARGES:** Monday thru Friday: Four (4) hours at rates named in Columns 1 and 3 or 4. A five (5) hours minimum will apply from May 1st to October 1st. Saturdays, Sundays and Holidays: Eight (8) hours at rates named in Columns 1 and 2 or 4.

▲◆ **NOTE AA - Travel charge** to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from final destination back to carrier's terminal.

0 - 15 miles	1/2 hour	16 - 30 miles	1 hour
