

Enclosed are two (2) copies of updates for 281st Revised Page 2 and 3rd Revised Page 14-E for All Ways World Wide Moving, Inc. (PA PUC #A-00113305) in Washington PA. This filing is for a DECREASE for some of their container & packing charges (applies to local moves travelling 40 miles & less and intrastate moves travelling 41 miles & over). Rates with a decrease are noted by a symbol (Ⓐ) in front of the dollar amount. I also changed the verbiage at the top of 3rd Revised Page 14-E showing that rates apply on shipments transported between points in Pennsylvania as All Ways World Wide Moving, Inc. was "grandfathered" for statewide operating authority in May 2015.
