Enclosed are two (2) copies of updates for 284<sup>th</sup> Revised Page 2, 178<sup>th</sup> Revised Page 2-A, 84<sup>th</sup> Revised Page 6, 2<sup>nd</sup> Revised Page 63-E, and Original Page 63-E-1 for L&J Transportation Companies, Inc. (PA PUC #A-00109787) in Pottstown PA. This filing is for an INCREASE in their local Non-Peak Season hourly rates and the addition of Peak Season hourly rates. Also ADDED a charge for travel time when the distance of origin and destination from carrier's terminal is over 40 miles. Carrier ADDED an exception page (Original Page 63-E-1) for Full-Value Protection. Verbiage was changed at the top of 2<sup>nd</sup> Revised Page 63-E showing that rates apply on shipments transported between points in Pennsylvania as L&J Transportation Companies, Inc. was "grandfathered" for statewide operating authority in May 2015.
