I received notice of cargo cancellation because of no insurance, I had 10 days to comply. At the bottom of the notice it states "Please notify Commission if no longer in business; any questions call Motor Carrier Service and Enforcement Division, Bureau of Investigation and Enforcement, 717-787-1227".

On 02/10/20 1:37PM, I called that number and left a message concerning letter. A woman returned my call at 1:55PM from phone #717-783-5945. I told her that I was closing my trucking business and had taken the truck off the road 12-31-2019. The plates were sent to Harrisburg by Hinkler's Notary Service 01-02-2020 and insurance was then cancelled. She told me that I had to notify PUC about closing the business in letter form, and that she would send me the form. I got the Form AR-19-MC on Friday, 02-14-2020. I completed the form on Mon., 02-17-2020 and mailed it Tues. 02-18-2020. I made sure to complete the "Authorization for Abandonment" portion of the form. I am including a copy of it with this letter.

02-20-2020 I received the letter that document C-2020-3018557 was in. I do not think this document should continue because as soon as I was notified of the insurance notification problem, I called the Motor Carrier Services and Enforcement Division and followed her instructions. I mailed my letter to PUC on 02-18-2020 and you mailed this letter to me on 02-18-2020. Just so you know, any US Mail from this area has to go to Pittsburgh to be processed.

The last day I worked the truck was 11-01-2019. I parked it on 11-26-2019, turned the license in 01-02-2020. I am 76 yrs old and now retired. The truck is up for sale.

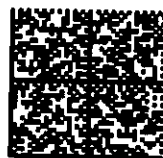
