# PREHEARING CONFERENCE MEMORANDUM OF YORK COUNTY PLANNING COMMISSION

## TO: THE HONORABLE ELIZABETH H. BARNES

Pursuant to the January 31, 2020 Fourteenth Prehearing Order in this proceeding and 52 Pa. Code § 5.222(d), York County Planning Commission (YCPC), by and through its attorneys, Hawke McKeon & Sniscak LLP, respectfully submits this Prehearing Conference Memorandum.

## I. <u>HISTORY OF PROCEEDING</u><sup>1</sup>

On September 19, 2019, YCPC executed a Joint Partial Settlement with Transource PA (YCPC Settlement) resolving all issues in this proceeding as they relate to YCPC provided, *inter alia*, that Transource amended its application filed with the Commission consistent with the YCPC Settlement. The YCPC Settlement was filed with the Commission on October 17, 2019.

On January 29, 2020, Transource served the Joint Amended Application. On January 31, 2020, YCPC provided a Status Report that indicated it was continuing to review the Joint Amended Application.

## II. <u>ISSUES</u>

YCPC has reviewed the Joint Amended Application and does not believe it is inconsistent with the YCPC Settlement. As such, the only issue in this proceeding YCPC intends to pursue is supporting the YCPC Settlement and approval of the Joint Amended Application. YCPC will file its statement in support of the YCPC Settlement pursuant to the next procedural order issued in this proceeding.

#### III. PROPOSED WITNESSES AND SUBJECT OF THEIR TESTIMONY

YCPC does not intend to present any witnesses or additional testimony. YCPC's testimony and exhibits were already admitted into the record of this proceeding.
