



AND NOW comes National Fuel Gas Distribution Corporation (“National Fuel”), by and through its counsel, and in compliance with Paragraphs 1(a) through 1(e) of the Final order of the Pennsylvania Public Utility Commission (“Commission”) entered December 27, 2019 (“Final Order”), in the above-captioned matter, submits and certifies the following:

1. By the Final Order, the Commission approved the Application of National Fuel at A-2018-3005258 for Approval of the Abandonment of Natural Gas Service to Three (3) Natural Gas Service Customers located in Scrubgrass Township, Venango County, Pennsylvania, subject to the terms and conditions set forth in the final order.


2. Paragraph 1(a) of the Final Order approved National Fuel’s the payment of \$11,700.00 to John Smith;¹ Paragraph 1(b) of the Final Order approved National Fuel’s the payment of \$11,873.73 to Dennis Kemery; and Paragraph 1(c) of the Final Order approved National Fuel’s the payment of \$16,980.63 to Anthony Ricciardella (collectively the “Customers”) to help defray the cost of converting to propane.

3. Pursuant to Paragraph 1(d) National Fuel purged and capped the service line and gathering line, which had been used to deliver gas to the Customers. National Fuel completed its work on March 5, 2020. National Fuel completed its work in compliance with the applicable Gas Safety regulations.

¹ Consistent with National Fuel’s letter to Secretary Chiavetta dated December 10, 2019 and the requests of John Smith, National Fuel issued the payment to the current owners of the property, Andrew and Katelyn Stutzman.

4. In Compliance with Paragraph 1(e) of the Final Order, National Fuel hereby certifies that it has fully complied with the terms and conditions of the Final Order. The Verification of Michael E. Young, Senior District Manager of National Fuel Gas Distribution Corporation is attached in support of this notice for abandonment.


