JUANA A VIDAL HERBY REDQUESTS AN APPEAL OF THE COMPLAINT FOR C-2020-3018414

1) THE RESPONDENT, JUANA A VIDAL, HEREBY STATES THAT SHE RECEIVED A NOTIFICATION OF AUTHORITY APPLICATION DISMISSAL NOTICE FROM THE PENNSYLVANIA PUBLIC UTILITY COMMISSION, ON OR ABOUT NOVEMBER 28, 2019 THE LETTER WAS DATED NOVEMBER 25, 2019, STATING THAT THE APPLICATION WAS BEING DISMISSED FOR FAILURE TO FILE A TARIFF ESTABLISHING JUST AND REASONABLE RATES.

2) JUANA A VIDAL CONTACTED THE PENNSYLVANIA PUBLIC UTILITY COMMISSION AND WAS ADVISED TO SUBMIT A PETITION FOR RECONSIDERATION ALONG WITH THE TARIFF.

3) JUANA A VIDAL SUBMITTED TO THE COMMISSION A PETITION FOR RECONSIDERATION, DATED DECEMBER 11, 2019, WHICH WAS RECEIVED BY THE COMMISSION.

4) JUANA A VIDAL, APPLICANT/RESPONDENT RECEIVED NO FURTHER COMMUNICATIONS FROM THE PENNSYLVANIA PUBLIC UTILITY COMMISSION, AND WAS MISINFORMED THAT SHE WOULD BE ABLE TO PROVIDE PASSENGER TRANSPORTATION SERVICES FROM POINTS IN LUZERNE COUNTY.

5) ON JANUARY 29, 2020, JUANA A VIDAL HAD A DVCR INSPECTION, AS NOTED IN THE PENNSYLVANIA PUBLIC COMMISSION COMPLAINT, DATED MARCH 2, 2020, ITEM 4.


6) IMMEDIATELY UPON THE NOTED ACTION, JUANA A VIDAL ATTEMPTED TO CONTACT THE PENNSYLVANIA PUBLIC UTILITY COMMISSION, SPOKE WITH A MOTOR CARRIER ENFORCEMENT OFFICER AND WAS ADVISED TO CONTACT TATJANIA ROTH IN COMPLIANCE FOR POSSIBLE ASSISTANCE. MS. ROTH WAS CONTACTED AND JUANA A VIDAL WAS INFORMED THAT THE PETITION FOR RECONSIDERATION WAS FORWARDED TO THE OFFICE OF SPECIAL ASSISTANCE FOR REVIEW. JUANA A VIDAL CONTACTED LEEANN AT THE OFFICE OF SPECIAL ASSISTANCE AND WAS INFORMED THAT THERE WAS NO TIME FRAME AVAILABLE FOR PETITION RECONSIDERATION.

7) JUANA A VIDAL, HAS ATTEMPTED TO FOLLOW PROPER PROCEDURES AS PER PENNSYLVANIA PUBLIC UTILITY COMMISSION REGULATIONS. JUANA A VIDAL HAS INVESTED SIGNIFICANT FUNDS TO ESTABLISH AN OPERATING BUSINESS IN ORDER TO BE IN COMPLIANCE WITH ALL STATE REQUIREMENTS (DEPARTMENT OF STATE FILINGS, FINANCIAL RESPONSIBILITY REQUIREMENTS/INSURANCE).

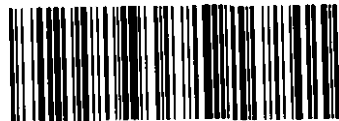

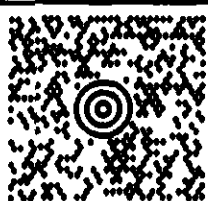

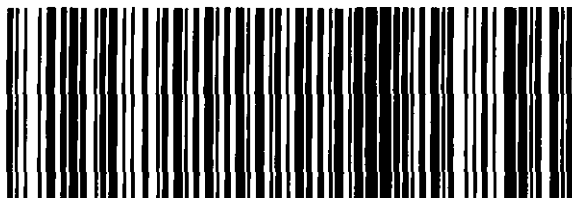
