To whom it may concern,

This is a response to the letter dated February 28, 2020 regarding PUC vs My-T Trippin, LLC dealing with the lack of insurance. We do not admit to any violation in this matter.

We closed the business-My-T Trippin, LLC- as of January 10,2020 and turned our tags in to PENNDOT on January 11,2020. We instructed our insurance company to cancel our policy and notify all concerned parties as of January 13th. Based on this letter, they did not complete the cancellation as requested by contacting the PUC. I have attached the documents showing the returned tags to PENNDOT.

It was my understanding that the insurance could not be cancelled until mid-February due to the filings per Prime insurance. I have heard nothing from them since my initial contact on January 13th through my insurance agent.

The buses are for sale and have not been moved off the premises since January 10th.

Please accept this explanation to why we no longer have insurance, it is expected that our PUC number will be cancelled as well. I do hope we are not going to be required to pay the fine, as we no longer have income from the closed enterprise.

For any violation of Section 3709, you may be subject to a fine of up to \$300 upon conviction, including any violation resulting from the conduct of any other persons operating, in possession of or present within the vehicle with your permission, if you do not with reasonable certainty identify the driver of the vehicle at the time the violation occurred.
