Re: XOOM Energy Pennsylvania, LLC Letter Petition to Reduce its Financial Security Level to 5% of Gross Receipts; Docket No. A-2012-2283821; Utility Code: 1114186

Dear Secretary Chiavetta:

Please accept this Letter Petition on behalf of XOOM Energy Pennsylvania, LLC (“XOOM Energy”) requesting that its required level of financial security be reduced to the level of 5% of its last twelve months of gross receipts. This request is being made pursuant to the Commission’s Bond Reduction Order at Docket No. M-2013-2393141<sup>1</sup> and is being submitted at least 90 days prior to the expiration date of XOOM Energy’s current security.<sup>2</sup> In support of XOOM Energy’s request, please find the following information and documentation:

- 1) XOOM Energy’s gross receipts in Pennsylvania for the most recent four quarters is attached hereto as Appendix A (**CONFIDENTIAL**);
- 2) XOOM Energy is current with its tax liabilities to the Commonwealth of Pennsylvania and is providing proof of its prepaid gross receipts taxes toward its estimated revenues for the current year in Appendix B (**CONFIDENTIAL**);
- 3) A letter evidencing XOOM Energy’s compliance with Alternative Energy Portfolio Standards requirements is attached hereto as Appendix C (**CONFIDENTIAL**);
- 4) XOOM Energy has been licensed as an electric generation supplier in the Commonwealth of Pennsylvania for over two years; and
- 5) XOOM Energy is compliant with the Commission’s annual and supplemental fee requirements.


