Dear Secretary Chiavetta:

In response to your March 13, 2020 letter to me, please be advised that the undersigned represents Energy Harbor LLC (f/k/a FirstEnergy Solutions Corp. or “FES”), a licensed electric generation supplier in the state of Pennsylvania operating under License No. A-110078.

On February 27, 2020, FES emerged from Chapter 11 bankruptcy under a new name, Energy Harbor LLC (“Energy Harbor”). Although Energy Harbor is the same entity as its predecessor FES (e.g., both FES and Energy Harbor have the same employment identification number, or EIN, and the same Dun & Bradstreet DUNS #), Energy Harbor is no longer affiliated with any of the FirstEnergy Corp. corporate family, including the FirstEnergy Corp. jurisdictional public utilities in Pennsylvania (Metropolitan Edison Company, Pennsylvania Electric Company, Pennsylvania Power Company and West Penn Power Company). Importantly, FES did *not* transfer or assign its license, but instead will simply operate under the new Energy Harbor name and under the same EIN and DUNS #.

As such, Energy Harbor hereby requests that the name on the aforementioned license be changed from FirstEnergy Solutions Corp. to Energy Harbor LLC. Energy Harbor’s contact information is as follows:

<sup>1</sup> On March 13, 2020 Energy Harbor filed with the Commission an Application for a license to supply natural gas services in the Commonwealth of Pennsylvania as a Natural Gas Service Supplier. No docket number has yet been assigned.

1. You are receiving this notice because you may be a retail electricity customer of FirstEnergy Solutions Corp. ("FES" or "FirstEnergy Solutions"). FirstEnergy Solutions is a Debtor in the above captioned chapter 11 cases (collectively, with its subsidiaries and affiliates that commenced chapter 11 cases, the "Debtors"). Please read this notice carefully as your rights may be affected by the transactions described herein.

2. Name Change. Please take notice that FES has changed its name to Energy Harbor LLC upon emergence from bankruptcy.

3. Confirmation of the Plan. On October 16, 2019, the United States Bankruptcy Court for the Northern District of Ohio, Eastern Division (the "Bankruptcy Court"), entered the *Order Confirming the Eighth Amended Joint Plan of Reorganization of FirstEnergy Solutions Corp., et al., Pursuant to Chapter 11 of the Bankruptcy Code* [Docket No. 3283] (the "Confirmation Order"). Among other things, the Confirmation Order confirmed the *Eighth Amended Joint Plan of Reorganization of FirstEnergy Solutions Corp., et al., Pursuant to Chapter 11 of the Bankruptcy Code* [Docket No. 3278] (as amended, modified, or supplemented from time to time, the "Plan")<sup>2</sup> as satisfying the requirements of the Bankruptcy Code, thereby authorizing FirstEnergy Solutions Corp. and its debtor affiliates (collectively, the "Debtors") to implement the Plan on the Effective Date.
