This letter is to inform you that pursuant to Paragraph 39 of the Joint Petition for Approval of Settlement, the Office of Attorney General and the Office of Consumer Advocate have disbursed the funds remaining in the Refund Pool from the above-captioned case to the utility Hardship Funds as provided for in this Settlement provision. The remaining funds, in the amount of \$395,666.29 were provided on March 26, 2020 allocated to each fund by the ratio of Pa.G&E's customers in the EDC's territory to the total number of Pa.G&E's customers as called for in the Settlement. The amount provided to each fund is as follows:


