Re: Electric Choice Quarterly Report for Patriot Energy Group, Inc. (Utility Code 1111352) for the Quarter Ending 3/31/2020

Dear Secretary Chiavetta:

Enclosed please find a confidential and public redacted version of the Electric Choice Annual Report for Patriot Energy Group, Inc. ("Patriot") for the first calendar quarter of 2020. As Patriot is a broker, no gross receipts are reportable for 2020.

Patriot respectfully requests confidential treatment for not only the kilowatt-hour total for the year, but also the breakout totals by EDC. Confidential treatment for its clients' usage total, as well as the totals by EDC, is appropriate because such information, although pertinent to the Commission's mandate to monitor competition in the electricity market, is competitively sensitive information. Given the highly competitive nature of the industries in question, public disclosure of such information would competitively harm Patriot by providing competitors with unfettered insight into Patriot's foothold in the Pennsylvania market, distribution of clients in the several EDC and geographic areas, and the relative size of its client base. This information would ordinarily be vigorously protected and not released to third parties absent a strict non-disclosure agreement. Moreover, such information would only be available to the public and Patriot's competitors, absent confidential treatment, but for the Commission's requirement to file the reports in question. The intent of the Commission's reporting requirement is to evaluate the state of the competitive electricity market. Granting confidential treatment for the usage data would permit Commission staff to gather the data it requires, but also prevent harmful disclosure. Therefore, the kilowatt-hour total on page 1 of the report and the EDC-by-EDC breakout on page 2 of the report should be accorded confidential treatment and not be made part of the public record or otherwise disclosed to the public.
