On March 27, 2020, UGI Utilities, Inc. – Gas Division and UGI Utilities, Inc. – Electric Division (“UGI”) filed two (2) reports for calendar year 2019 in accordance with reporting requirements under 66 Pa. C.S. §1410.1(3) (Reporting Requirements re: Accounts Exceeding \$10,000 in Arrearages), and §1410.1(4) (Reporting Requirements re: Medical Certificates).
