Dear Secretary Chiavetta:

In accordance with 52 Pa. Code § 54.39(a), enclosed for filing with the Commission are the following documents:

1. Two redacted copies of the Electric Choice Quarterly Report for the period of January 2020 through March 2020 (“Quarterly Report”) of Palmco Power PA, LLC d/b/a Indra Energy (“Indra”).
2. Two unredacted copies of a confidential version of Indra’s Quarterly Report.

Pursuant to 52 Pa. Code §§ 5.365(b) and 54.39(d), as well as the Commission’s July 20, 2000 Order in Docket Nos. P-00991752; P-00991753; P-00991755, *Petitions of Exelon Energy; Reliant Energy Retail, Inc.; and Statoil Energy Services, Inc. for Protective Order* (the “July 2000 Order”), Indra hereby respectfully requests confidential treatment and exception from public disclosure for certain information contained in the Quarterly Report. Specifically, in addition to the total amount of Indra’s gross receipts, which is afforded confidential treatment pursuant to the July 2000 Order, Indra requests that, the following information also be granted confidential treatment:

- a. Indra’s total retail sales (kWh) for the period from January 2020 through March 2020, as reported on page 1 of the Quarterly Report (“Total Retail Sales”); and

- b. Indra's retail sales (kWh) by Electric Distribution Company ("EDC") service area for the period from January 2020 through March 2020, as reported on page 2 of the Quarterly Report ("Retail Sales by EDC Territory") (the Total Retail Sales and Retail Sales by EDC Territory are hereinafter referred to as the "Retail Sales Information").

Indra requests confidential status of the Retail Sales Information because its release would unduly harm Indra's business and competitive interests. The Retail Sales Information sets out commercially sensitive proprietary data which, if disclosed, would enable competitors to obtain valuable competitive information concerning Indra's prices and corporate strategies, give an unfair advantage to Indra's competitors, and cause economic injury to Indra. The Retail Sales Information is treated confidentially by Indra and is not available to the general public.

For the reasons stated above, Indra respectfully requests that its Retail Sales Information be deemed to be confidential material exempt from public disclosure under 52 Pa. Code §§ 5.365(b) and 54.39(d).


